TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Any entry which does not comply with these Terms and Conditions is invalid.
- 3. The Promoter is CNW Pty Ltd (ABN 48 009 669 836) of 675 MacArthur Avenue Central, Pinkenba QLD 4008, telephone: (07) 3907 8388 ("CNW").
- 4. Entry is only open to Australian businesses with a valid ABN (each an "Eligible Business").
- 5. Employees (and their immediate families) of CNW and agencies associated with this promotion are ineligible to enter.
