

## Haneco Time to Chill Out Promotion with CNW Electrical Wholesale

### TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Any entry which does not comply with these Terms and Conditions is invalid.
3. The Promoter is CNW Pty Ltd (ABN 48 009 669 836) of 675 MacArthur Avenue Central, Pinkenba QLD 4008, telephone: (07) 3907 8388.
4. Entry is only open to Australian businesses with a valid ABN (each an “Eligible Business”).
5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
6. Persons under 18 are ineligible to enter.
7. The promotion commences at 6:00am AEST on 01/02/2025 and concludes at 5:00pm AEST on Sunday 31/03/2025 (“**Promotional Period**”). All times referred to herein are AEST, as applicable in QLD.
8. To be eligible to enter via a spend entry method, an authorised representative on behalf of an Eligible Business, must spend the following with the Promoter during the Promotional Period (collectively referred to as a “**Qualifying Transaction**”):
  - Spend \$250 (exclusive of GST) or more on any Haneco product with CNW, online or in-store, to be eligible to receive one (1) entry into the Prize draw.
  - Multiple qualifying entries permissible
  - For each multiple of \$250 (exclusive of GST) spent in a single transaction, the customer will receive one (1) entry into the draw
- ‘**Eligible products**’ are all Haneco products including Kasta, Haneco Xero & Lucesco product purchased through CNW Electrical Wholesale.
9. Entries are deemed to be received at the time of receipt by the Promoter. The Promoter is not responsible for failure to receive an entry for any cause beyond its control.
10. Eligible Businesses must have a CNW account and must not have any outstanding charges in order to claim a prize.
11. Eligible Businesses must retain their original purchase receipt(s) and/or invoice(s) for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an Eligible Business’ entries and forfeiture of any right to a prize. Purchase receipt(s) and/or invoice(s) must clearly specify the store of purchase, the purchase amount and that the purchase was made during the Promotional Period but prior to entry.

12. The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Businesses and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
13. Incomplete or indecipherable entries will be deemed invalid.
14. If there is a dispute as to the identity of an Eligible Business, the Promoter reserves the right, in its sole discretion, to determine the identity of the Eligible Business.

Each Major Prize winner will win one (1) BLUETTI Portable Fridge Freezer + Battery Pack RRP \$2198. The winning Eligible Businesses will be notified in writing within five (5) business days of the applicable draw and the winner name published online at <https://shop.cnw.com.au> from Tuesday 8<sup>th</sup> April 2025. In the event that a winner is from SA, their name will also be published in The Advertiser by 30<sup>th</sup> April 2025.
19. A draw for any unclaimed prizes may take place on 15/04/2025 at the same time and place as the original draw, subject to any directions from a regulatory authority. Winners, if any, will be notified in writing within two (2) business days of the draw and their names will be published online at <https://shop.cnw.com.au> from 15/04/2025. In the event a winner is from SA, their name will also be published in The Advertiser by 01/05/2025.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the promotion, or out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner, Prize Recipient or Eligible Business; or (f) use of a prize.
