TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Any entry which does not comply with these Terms and Conditions is invalid.
- 3. The Promoter is Sherriff Electrical Wholesalers (Australia) Pty Limited (ABN 63 010 059 837) of 675 MacArthur Avenue Central, Pinkenba QLD 4008, telephone: (07) 3907 8388.
- 4. Entry is only open to Australian businesses with a valid ABN (each an "Eligible Business").
- 5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

- 9. To be eligible to enter, an authorised representative on behalf of an Eligible Business, must purchase the following Eligible Products from the Promoter during the Promotional Period (collectively referred to as a "Qualifying Transaction"):
