## **Sherriff Electrical National Promotion 2024**

## **TERMS AND CONDITIONS**

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Any entry which does not comply with these Terms and Conditions is invalid.

- 4. Entry is only open to Australian businesses with a valid ABN (each an "Eligible Business").
- 5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
