

Sherriff Electrical National Promotion 2024

TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Any entry which does not comply with these Terms and Conditions is invalid.
3. The Promoter is Sherriff Electrical Pty Limited (ABN 63 010 059 837) of 675 MacArthur Avenue Central, Pinkenba QLD 4008, telephone: (07) 3907 8388 ("Sherriff").
4. Entry is only open to Australian businesses with a valid ABN (each an "Eligible Business").
5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
6. Eligible Entrants must have an active Sherriff Trading account with Sherriff Electrical Wholesalers.
7. The promotion commences on Friday 01/11/2024 and concludes at 11:59 pm AEST on Saturday 30/11/2024 ("**Promotional Period**"). All times referred to herein are AEST, as applicable in QLD.
8. Eligible Entrants must be within the Sherriff trading terms throughout the Promotional Period and must not have overdue monies owing as at the 01/11/2024 in order to be eligible to claim any prize.
9. To be eligible to enter, an authorised representative on behalf of an Eligible Business, must purchase the following Eligible Products from the Promoter during the Promotional Period (collectively referred to as a "**Qualifying Transaction**"):
 - Purchase 10 x eligible Haier Air-conditioning units, during the promotion period and receive one (1) x All Access voucher for Maui Jim Sunglasses RRP \$700 and gift pack (sunglass cloth & case).
 - Account customers only.
 - First ten (10) eligible customers only will receive the prize listed above.
 - Multiple purchases allowed.
10. '**Eligible Products**' are eligible Haier Air Conditioning Units purchased through Sherriff Electrical Wholesalers listed on Appendix 1.
11. Project orders are allowed.
12. Eligible Businesses must retain their original purchase receipt(s) and/or invoice(s) for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an Eligible Business' entries and forfeiture of any right to a prize. Purchase receipt(s) and/or invoice(s) must clearly specify the store of purchase, the Eligible Products purchased and that the purchase was made during the Promotional Period.

13. The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Businesses and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
14. The Promoter reserves the right, at any time, to charge the value of the prize to the customer, if they are not compliant with terms and conditions set out in the customer's credit account.
15. The Promoter reserves the right, in event of the Prizes being unavailable to conclude the promotion.
16. Incomplete or indecipherable entries will be deemed invalid.
17. If there is a dispute as to the identity of an Eligible Business, the Promoter reserves the right, in its sole discretion, to determine the identity of the Eligible Business.

Any cost associated with accessing the promotional website is the responsibility of the individual submitting the entry on behalf of the Eligible Business and is dependent on the Internet service provider used. The use of any automated entry software or any other mechanical or electronic means that allows an individual/Eligible Business to automatically enter repeatedly is prohibited and will render all entries submitted by that individual/Eligible Business invalid.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the promotion, or out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner, Prize Recipient or Eligible Business; or (f) use of a prize.

The Promoter collects personal information ("PI") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
